He teaches numerous short courses on timber taxation, estate planning, forest finance, and management of private timberland. He has written several landowners guides and numerous technical publications on forestry investment analysis, timber taxation, and forest management. His tax columns are in Virginia Forests magazine and other magazines that are widely read.
